The annual American College of Surgeons (ACS) Surgeons and Engineers: A Dialogue on Surgical Simulation meeting will return in 2022 as a full-day event on **Wednesday, March 2** at the Swissôtel in Chicago, IL.

The meeting will serve as a venue for the unique partnership between surgeons, surgical educators, academic and industry engineers, and scientists to continue the dialogue between the medical simulation and engineering communities.

The objective of this meeting is to provide a novel forum for the exchange of challenges and potentially applicable technologies between surgeons, surgical educators, academic and industry engineers, and scientists. Surgeons and surgical educators will present the needs and challenges encountered in their delivery of surgical education. Academic and industry engineers and scientists will have the opportunity to present existing technologies—or those in development—that have the potential to be applied to and successfully address the presented challenges. Through this exchange, we endeavor to promote future collaboration between the surgical and engineering communities.

The full-day 2021 ACS Surgeons and Engineers: A Dialogue on Surgical Simulation meeting was held virtually on March 10 with notable success. The meeting attracted 126 registrants from the U.S. and 15 other countries. Twelve highly scored abstracts were selected and presented as live oral presentations, and 26 abstracts were presented on a virtual poster presentation site. Considering the strong positive responses received in 2019 and 2021, we are estimating to have 150 to 200 attendees at the 2022 meeting.

This meeting is presented by the American College of Surgeons Division of Education Simulation-Based Education and Training team (SBSET) in coordination with the ACS Division of Education Engineering Committee.

Exhibits will be located in Zurich ABC. Coffee breaks and the reception (tentative) will also be held in this area.


